- -- North Korea is a top national security priority for the United States. As we have consistently said, we expect all states to fully implement all UN Security Council resolutions related to North Korea, and call on countries to take additional action to increase diplomatic and economic pressure on the regime. North Korea has demonstrated its ability and willingness to evade sanctions in any way possible. We ask all members of the global community to be just as diligent in preventing these evasions.
- -- We would like to inform your government that on January 24, the United States announced new North Korea-related sanctions designations of nine entities and 16 individuals, and blocked six vessels in response to North Korea's ongoing development of weapons of mass destructions (WMD) and their means of delivery and illicit activities in continued violation of multiple United Nations Security Council resolutions (UNSCRs). The United States also recently took similar actions on December 26, 2017, designating two individuals and on November 21, designated one individual and 13 entities and blocked 20 vessels.
- -- These sanctions target agents of the Kim Jong Un regime supporting North Korea's WMD and delivery programs, financing, oil procurements, and other illicit businesses. These sanctions also target third-country persons with long-standing commercial ties to North Korea, as well as the transportation networks that facilitate North Korea's revenue generation and operations.
- -- North Korea is a paramount national security priority for the United States. Both President Trump and Secretary Tillerson have stated that the status quo in North Korea is unacceptable.
- -- All assets of the designated individuals and entities that are under the jurisdiction of the United States or in the possession or control of U.S. persons are blocked, and U.S. persons are generally prohibited from engaging in transactions with these designated persons. Any persons or entities in your jurisdiction that provide material support to these and other designated individuals and entities could themselves become subject to designation by the United States. We recommend that you share this information with companies, financial institutions, entities, individuals, or other persons in your jurisdiction who may transact with designated individuals and/or entities.
- -- The United States has designated 11 shipping companies and blocked 26 vessels since November 21, 2017. Previously, the United States designated and/or blocked dozens of DPRK shipping companies and associated vessels.
- -- According to the UN's DPRK Panel of Experts' midterm report on September 5, 2017, the DPRK continues to export UN Security Council resolution-prohibited minerals both directly from its territory as well as via transshipment through other States. The Experts stated that the DPRK has violated sectoral sanctions through the continued export of commodities prohibited in the resolutions, generating several hundred million dollars in revenue this year.
- -- This and previous Panel of Experts' reports have noted the DPRK's use of false vessel registration/flags, fake certificates and other falsified documentation, defunct insurance certificates, false broadcasting of Maritime Mobile Service Identity (MMSI) numbers and call signs, turning off Automatic Identification System (AIS) transmissions, and other activities that are used to evade sanctions and that may circumvent international maritime law.

- -- Five of the individuals sanctioned on January 24 were North Korean individuals linked to North Korean financial networks.
- -- As noted in the UN's Panel of Experts report released in February 2017, North Korea's financial networks have adapted to UN sanctions, using evasive methods to maintain access to formal banking channels. The networks behind this activity consist of a core of agents who are highly experienced and well trained in mobilizing money, people, and goods across borders. These agents use non-North Korean nationals as facilitators and rely on numerous front companies with no paper trail connecting them to North Korea. The business conducted by these networks generates significant revenue for North Korea.
- -- To date, the United States has identified 26 overseas North Korean financial representatives in China, and a number of others located in other countries. Some of these individuals have been associated with cash transfers and hand-carrying funds to North Korea, high volume US-dollar transactions, overseas bank accounts, and North Korean front companies.
- -- Many of these individuals and entities are also directly linked to UN-designated entities, including Office 39, the Reconnaissance General Bureau, Daesong Trading Company, Ilsim International Bank, Foreign Trade Bank, Bank of East Land, and Daesong Bank.
- -- We note that multiple UN Security Council resolution provisions that require Member States to freeze the assets of certain individuals or entities and/or prohibit the entry into, or transit through their, territories of certain individuals may also apply to the travel and/or financial assets of these individuals and entities.
- -- We request that your government investigate whether these individuals and entities maintain any financial or economic resources in your jurisdiction. We further urge you to immediately freeze any such resources you may find, and prevent such resources from being accessed by North Korea or individuals acting on its behalf. We also urge you to deny the blocked ships port entry and/or any maritime-related services, such as insurance or classification. Should you take any such actions, we request that you share details on the results of your investigation with our government.

-- We also would like to share with you the attached image, taken on October 19, 2017, which depicts an attempt by one of these vessels, the RYE SONG GANG 1, to conduct a ship-to-ship transfer, possibly of oil, in an effort to evade sanctions. Such a transfer is prohibited under UN Security Council resolution 2375, adopted September 11, 2017.
