**No. 7 of 2019**

**Companies (Financial Services) (Fees) (Amendment) Order, 2019.**

In exercise of the powers conferred by sections 219 and 240 of the Companies Act, the Minister makes the following Order:

*[Published 24<sup>th</sup> January 2019, Extra Ordinary Gazette No. 5 of 2019]*

**1. Citation.**

This Order may be cited as the Companies (Financial Services) (Fees) (Amendment) Order, 2019.

**2. AMENDMENT TO FINANCIAL SERVICES (FEES) ORDER.**

The Financial Services (Fees) Order as set out in the Second Schedule to the Companies Act is amended as follows:

(a) by inserting immediately after paragraph 3, the following new paragraph

“ 4. Pursuant to section 136 (2) (b) of the Act, the fees payable to the Registrar for a copy of a report made by inspectors shall be at the rate of two (2) dollars per page of the report.”.

(b) by replacing the Schedule to the Order as follows:
