KRAPE MYRTLE CO LTD served as the operator of Panamanian-flagged **NORD STAR** (IMO 9323596). **NORD STAR** transported Venezuelan oil as recently as July 2025. The United States identified **NORD STAR** as blocked property in which **KRAPE MYRTLE CO LTD** has an interest.

3. (U) The United States designated Hong-Kong-registered entity **ARIES GLOBAL INVESTMENT LTD** for operating in the oil sector of the Venezuelan economy. This entity also has a registered address in Hangzhou, China. **ARIES GLOBAL INVESTMENT LTD** served as the registered owner of **DELLA**. The United States identified **DELLA** and **VALIANT**, another oil tanker, as blocked property in which Aries Global Investment LTD has an interest.

The United States is identifying **ROSALIND** as blocked property in which **WINKY INTERNATIONAL LIMITED** has an interest.
